Important Reminders

Covid-19 – Please remember that face masks are mandatory when entering all City Buildings, this includes the Harbormaster's Office.

2021 Slip Renter Parking Permits - 2020 parking permits have expired. The 2021 permits are available in the Marina office. They are \$5 each and are available only to slip renters.

Boat Ramp Permits – 2021 Boat Ramp Permits are now available as well. If you had a 2020 boat ramp permit, it will not expire until March 31, 2021 due to the closure during the dredging project. Boat ramp permits that are renewed in April will receive a 25% discount.

Online Slip Rental Payments - We encourage everyone to set up payments through your online banking. This will help slip renters avoid late fees and will keep in-person contact to a minimum due to Covid-19. You will need to reference the eight digit account number that is located on your invoice when setting up online payments through your bank. Checks can also be deposited in the drop box outside of the office door.

Marina Projects

Dock B Plumbing - All of the plumbing has been replaced. Please continue to disconnect your hoses when not in use in order to avoid the hose ends corroding onto the new hose bibbs.

Pedestals – All of the pedestals on Dock B and the North Wall will be replaced, with some of those replacements beginning in the next 7-10 days. Affected slip renters will receive further information regarding the project in an upcoming email.

Flagpole - You may have noticed the absence of the flagpole at the entrance to the Marina. The replacement flagpole has been ordered and we are still awaiting its arrival. Manufacturers are incurring production delays, of course due to Covid-19. We are continuing to monitor the shipment of the product so that the installation can be scheduled as soon as possible.

Boat Ramp Fee Payment Kiosk – A new electronic pay station has been installed at the boat ramp. We have been patiently waiting for information from the bank in order to complete the setup of the ramp kiosk. Once finalized, patrons will be able to pay the \$10 ramp fee using a credit card at the kiosk. A receipt will be printed to be placed on the dashboard of the vehicle as proof of payment. Cash payments can still be made in the office or by using the drop box next to the office door.
